

ORDINANCE NO. 2020-35

AN ORDINANCE TO AMEND ORDINANCE NO. 2019-02 BY ADDING SECTION 5 TO
EXTEND THE POLICE JURISDICTION OF THE TOWN OF LOXLEY

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF LOXLEY,
ALABAMA, as follows:

WHEREAS, on January 28th, 2019, the Town Council of Loxley, Alabama, did adopt Ordinance No. 2019-02 which annexed certain property, described below;

WHEREAS, on January 28th, 2019, when Ordinance No. 2019-02 was adopted the ordinance did not expressly indicate the extension of the municipal limits would include extending the Police Jurisdiction of the Town of Loxley, Alabama as required by Section 11-40-10 of the *Code of Alabama* (1975); and

WHEREAS, Ordinance No. 2019-02 is hereby amended to include Section 5 as follows:

Section 5. The Police Jurisdiction of the Town of Loxley, Alabama, shall be, and is hereby altered so as to include all of the territory here to before encompassed by the corporate limits of the Town of Loxley, Alabama, and in addition thereto the following described territory, to wit:

Commencing at the Northeast corner of the Northeast Quarter of the Southwest Quarter of Section 4, Township 5 South, Range 4 East, Baldwin County, Alabama; thence North 89°56'08" West, 84.15 feet to the west right-of-way of Baldwin County Road No. 68 and the point of beginning of the parcel herein described; thence South 00°03'59" West, along said west right-of-way, 1031.93 feet to the present north right-of-way of Interstate Highway No. 10; thence North 84°38'22" West, along said north right-of-way, 1182.60 feet to the P.T. of a curve to the right having a radius of 3691.45 feet; thence continue along said right-of-way and along said curve, a chord bearing and distance of North 84°11'17" West, 58.67 feet to the west line of said Northeast Quarter of the Southwest Quarter of said Section 4; thence North 00°18'03" East, along said west line, 916.90 feet to the northwest corner of same; thence South 89°56'08" East, along the north line of the Northeast Quarter of the Southwest Quarter of said Section 4, 1232.18 feet to the point of the beginning. LESS and EXCEPT all that property described in the condemnation of said right-of-way by the State of Alabama, as contained in Instrument No. 1291855, Pages 1-6.


The territory described in this ordinance shall extend the Police Jurisdiction of the Town of Loxley, Alabama effective January 1, 2021 pursuant to Section 11-40-10 of the *Code of Alabama* (1975).

NOW, THEREFORE BE IT RESOLVED, Ordinance No. 2020-35 is hereby adopted and hereby amends Ordinance 2019-02, to include Section 5 extending the Police Jurisdiction of the Town of Loxley, Alabama effective January 1, 2021.
